SECTION 4. FIRST-AID MEASURES

First-aid Measures

Inhalation

Remove source of exposure or move to fresh air. Get medical advice or attention if you feel unwell or are concerned.

Skin Contact

SECTION 6. ACCIDENTAL RELEASE MEASURES

Personal Precautions, Protective Equipment, and Emergency Procedures

Eliminate all ignition sources. Use grounded, explosion-proof equipment. Evacuate the area immediately. Isolate the hazard area. Keep out unnecessary and unprotected personnel. May accumulate in hazardous amounts in low-lying areas especially inside confined spaces, if ventilation is not sufficient.

Environmental Precautions

If the spill is inside a building, prevent product from entering drains, ventilation systems and confined areas. Do not allow into any sewer, on the ground or into any waterway.

Methods and Materials for Containment and Cleaning Up

Appropriate Engineering Controls
